Directions

Bristol Airport: there is a regular bus service between the airport and Temple Meads Station which takes approximately 30 minutes. Walk to Airport Terminal (Stand 1) for the 'A1 Airport Flyer'. Once you have arrived at Bristol Temple Meads railway station, follow the directions as listed below. Alternatively, taxi services will be available outside the airport.

Bristol Temple Meads railway station is a 6 minute walk from our offices. Pass through the ticket barriers and walk north-west towards Friary. Turn right onto Friary before continuing on to Meads Reach Bridge. Turn left onto Avon Street and the offices will be on the left.

Parking: Due to limited spaces, we do not offer car parking for our seminars or events. The nearest 24 hour pay and display car park is just off Avon Street, on the <u>corner of New Kingsley Road and Old Bread Street</u>, a couple of minutes' walk from our office.
